

1 **Resolution No. 2024-22**

2 **A Resolution of the City of Lincoln City Regarding Human Trafficking and Allowing**
3 **Informational Signs to Be Posted on City Property**

4 **WHEREAS**, Human trafficking is a matter of national and local concern; and

5 **WHEREAS**, the City of Lincoln City, by and through its City Council, desires to acknowledge
6 the importance of human trafficking and take action to address human trafficking locally; and

7 **WHEREAS**, the City of Lincoln City acknowledged Oregon Revised Statute (ORS) 377.880,
8 which allows the State of Oregon Department of Transportation, the State Parks and Recreation
9 Department, and the Travel Information Council to post informational materials about human
trafficking on rest stops owned and/or operated by those state agencies; and

10 **WHEREAS**, the City of Lincoln City desires to also post informational materials about human
trafficking on its properties; and

11 **WHEREAS**, the City Council authorization to allow the posting of informational materials
12 about human trafficking in conformity with ORS 377.880 shall not be construed to create a
13 public or limited public forum, nor shall it be interpreted to allow signage of any other type.

14 **NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF**
15 **LINCOLN CITY, AS FOLLOWS:**

16 **Section 1:** As used in this section, “nonprofit organization” means an organization described in
17 section 501(c)(3) of the Internal Revenue Code that is exempt from income tax under section
501(a) of the Internal Revenue Code.

18 **Section 2:** A nonprofit organization may supply to the City of Lincoln City copies of
informational materials about human trafficking.

19 **Section 3:** The nonprofit organization may not charge the city for the informational materials.

20 **Section 4:** The informational materials may not include the name of the nonprofit organization
21 or information on topics other than human trafficking. The materials must be limited in content
22 to objectively verifiable information, except that the materials may include, symbols, graphics or
similar devices, and must include the following:

23 (a) At least one toll-free hotline telephone number;

24 (b) At least one hotline text messaging number; and

25 (c) Translated versions of the information in languages other than English that are most
26 commonly spoken in this state.

27 **Section 5:** The form of the informational materials must include, but need not be limited to,
28 posters.

1 **Section 6:** Except as provided in this subsection, the city shall allow informational materials to
2 be posted in conspicuous locations in any roadside rest area that the city manages, including, but
3 not limited to, in rest room stalls. If the city determines that the materials have offensive or
4 inappropriate content, the city may refuse to display the materials or otherwise assist in
5 distributing the materials.

6 **Section 7:** The city may administer a volunteer program to assist with posting and maintaining
7 the informational materials described in this section. The city may adopt rules it considers
8 necessary for the implementation of the volunteer program.

9 **Section 8: Effective Date:** This resolution is effective as of the date of its adoption.
