**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LINCOLN CITY TO  
CREATE THE ENGAGE LINCOLN CITY AS HOC PUBLIC INVOLVEMENT  
COMMITTEE**

**WHEREAS**, on December 7, 2023, the Lincoln City Council adopted the 2043 Lincoln City Comprehensive Plan, which included an objective to prioritize the creation of an inclusive and transparent public involvement program; and

**WHEREAS**, the Lincoln City Planning Commission recommends the creation of an Ad Hoc Engage Lincoln City Advisory Committee to guide the development of a written citizen involvement program; and

**WHEREAS**, Goal 1 of the State of Oregon’s Statewide Planning Goals calls for the City to have a public involvement program that ensures the opportunity for the public to be involved in all phases of the land use planning process; and

**WHEREAS**, public involvement in the affairs of the City should extend beyond the Planning & Community Development Department’s land use planning process to include other City departments as appropriate; and

**WHEREAS**, the City Council desires to establish an Engage Lincoln City Public Involvement Ad Hoc Committee; and

**WHEREAS**, the meetings of the Engage Lincoln City Public Involvement Ad Hoc Committee will abide by public meetings law and be open to the public,

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LINCOLN CITY AS FOLLOWS:**

**Section 1:** The City Council hereby establishes and the City Council hereby authorizes the City Manager to direct the creation of an ad hoc committee to be known as the Engage Lincoln City Public Involvement Ad Hoc Committee.

**Section 2:** The Committee shall be ad hoc and shall terminate upon completion of the Engage Lincoln City citizen involvement program. The Committee shall consist of approximately four (4) Planning Commissioners, one (1) City Council Liaison, and up to a maximum of nine (9) community members to provide representation of the following:

- Neighborhood Organizations, e.g., the Nelscott Neighborhood Association or the Roads End Improvement Association;
- Youth and/or families with young children;
- Housing and social services organizations;
- Business and economic development;
- Hispanic organizations;
- Confederated Tribes of Siletz Indians; and

- Media outlets

**Section 3:** The recitals contained in the Whereas Clauses of this resolution, as well as other competent substantial evidence in the whole record of this proceeding are incorporated into this section by reference as if fully set forth herein and are adopted in support of this action.

**Section 4:** This Resolution is effective as of the date of its approval.
